Chief Romance

On June 9, 2026 at 1015 hrs., the complainant, Steven Polli, reported that on June 5, 2026, he received a threatening message through Facebook that was sent by the suspect, Cameron Locarno, on June 4, 2026 at 2056 hrs. See attachments for screenshots of the electronic messages.

On June 9, 2026 at 1350 hrs, I attempted to contact Locarno via telephone, [REDACTED], a a phone number that was located in the Valcour computer system from a prior incident handled by another agency. The phone call was forwarded to voicemail and I left a message for Locarno to call me back to further investigate this incident.

On June 9, 2026, at 2:00 pm, Cameron Locarno called the Hinesburg Police Department to discuss the Facebook message. Locarno confirmed that his full name is Cameron C. Locarno, date of birth [REDACTED], phone number [REDACTED], and that he resided at [REDACTED].

During the phone conversation, Locarno admitted to sending the Facebook message to Steven Polli after finding his profile on Facebook.

I advised Locarno that he had the option of reporting to the Hinesburg Police Department to receive his citation regarding the charges applicable to this incident or to report to the Town of Barre Police Department, closer to his residence, to obtain his citation. Locarno elected to go to the Town of Barre Police Department.

During the conversation, I advised Locarno not to contact Polli in any manner in the future, to include electronic means, by phone, or in person. Locarno acknowledged that he was notified of this restriction.

I contacted Corporal De Prato, of the Town of Barre Police Department, in regards to Locarno reporting to their department to be cited for a court appearance in Chittenden County Court on July 23, 2026, at 0815 hrs.

On June 9, 2026, at 1525 hrs., I contacted Locarno and instructed him to report to the Town of Barre Police Department, either today by 1600 hrs., or anytime tomorrow between the hours of 0800 and 1600 hrs. to be cited for Title 13 VSA-1027(a) and Title 13 VSA-1455(a).

On June 10, 2026, at approximately 1155 hrs., Locarno reported to Barre Town Police Department and was issued the citation by Corporal De Prato. The citation was scanned and uploaded to the case for reference.

Cameron C. Locarno (DOB: [REDACTED]) was cited by the Town of Barre Police Department on June 10, 2026, to appear in Chittenden Superior Court on July 23, 2026, at 8:15 am for committing the offenses of Disturbing peace by use of telephone or other electronic communications, a violation of Title 13 VSA-1027(a) and Hate-motivated crime, a violation of Title 13 VSA-1455(a).
